President’s Report – David Fogel

Fogel reported on the state of the CIS Society, and provided highlights on the presentations to be made by the respective officers.

Fogel also discussed current issues, the updated reporting structure for Members Activities and Technical Activities committees to stagger full reports and highlights and announced the schedule for the AdCom meetings for 2009.

VP Members Activities Report – Slawo Wesolkowski

Wesolkowski provided membership statistics showing the steady growth of CIS. He also highlighted the accomplishments of the Members Activities Committee and discussed the restructuring of the subcommittees.

Wesolkowski presented the Membership Development plan providing detail on short term, midterm and long term plan activities.

Awards Committee Chair Report – Gary Yen

Yen expressed thanks to Enrique Ruspini and Pei-Wen Kao regarding the development and launch of the CIS Awards website. Yen briefly discussed the four new awards that will be presented to the AdCom at the November meeting.

Fellows Committee Chair Report – Xin Yao

Reported that five fellows have been confirmed. There was training for Fellow Chairs and all committees have received the nominations packets. Yao also discussed the future goals of the committee which include being more proactive seeking nominees, publicity, a possible column in the magazine for Fellows, social event to encourage nominations.

Distinguished Lecturers Committee – Leszek Rutkowski

Reported on committee membership consisting of 21 speakers. He discussed the new procedure for appointing speakers and the current activities of the committee.

Education Committee – Rami Abielmona

Reported on the activities and goals of the committee, research and travel grants awarded for the 2008 conferences, the Walter J. Karpus summer research grant proposals and the Chile Summer School. Additional requests from new conferences for grants, budget performance creation of an operations manual were also discussed.

Multimedia Tutorials Committee – Deana Delp presented by Slawo Wesolkowski

Reported on the current tutorials available for viewing, the CIS funded tutorials available on IEEE Expert Now and related statistics, and the future initiatives that will attract application demonstrations and code sharing from algorithms and projects. Ideas are needed from the committee members to encourage development of future tutorials.

Chapters Sub-Committee – Bruno Di Stefano presented by Slawo Wesolkowski

Reported on the activities of the committee and the formation of 11 new Chapters beginning in January 2007 to present. Currently there are 12 sections in the process of forming chapters for 2008 – 2009, the process of forming a chapter or joint chapter was discussed. A discussion on the on the use of webinars to enhance the value of membership, the details from a program currently being done by the CIS Toronto Chapter were reported and the opportunity to expand this program to Regions 1 – 7 were discussed.

CIS Website – Julia Chung presented by Slawo Wesolkowski

Reported on the changes made to the CIS website largely the internal structure of the website. The update of the name lists of the CIS Officers and Committee members were made according to the VPs' and the committee chairs' requests by email. The content of several pages were also updated according to the requests of the corresponding chairs by email. The consistency of the content is being updated and correct for uniformity across the site. Updates were made to the Travel Grant Application and the Awards Nomination websites.

Women in Computational Intelligence Committee – Fahmida Chowdhury

Reported on the composition of the committee, creation of a newsletter, and activities geared toward energizing the WCI-Community to get more involved in CIS activities such as reviewers, session chairs and conference committee members. The future goals of the committee are to invite members to participate and work with chapters to generate excitement and participate in activities to encourage growth across the society.

GOLD Sub-Committee – Damien Coyle

Reported on the activities of the committee and its membership. Highlighted the membership statistics of the IEEE GOLD and CIS GOLD members. The objectives of the committee were discussed along with future plans to increase activities, through special columns in the magazine, student travel grant opportunities, and additional interaction through electronic means such as Second Life, Facebook and Linked In. A test of this opportunity is currently underway within the IEEE CIS UKRI Chapter.

CIS – eletter – Derong Liu

Reported on the status of eletter highlighting the opt-in circulation is over 17,000 subscribers. The format of the eletter is designed to emphasize the identity of the Society and CI technologies. There is a stable source of submissions for the eletter for the following topics: IEEE CIS News and Announcements, Doctoral Dissertations, Career Opportunities, Bookshelf, Conference Calendar, and Call for Papers. The Members Activities committee is currently working on guidelines for the eletters.

History Sub-Committee – Gary Fogel

Reported on the establishment of the CIS History Committee and the development of the CIS History website that serve as a virtual museum for CIS History. The content is under development and currently there are future plans to collect biographies, oral histories and CIS reference material of early contributions in the field.

Nomination Committee Report – Vincenzo Piuri

Piuri reported on Nominations and Appointments committee activities. The request for nominations was broadcast to the membership as well as posted to the CIS website with a deadline of May 10, 2008. According to the bylaws 10 – 15 names will be placed on the ballot.

Division X Director Report – Bill Gruver

Thanked the Society for the opportunity to attend the AdCom meeting. Gruver provided information on the Board of Directors and that society members have served as Past Division Directors. Gruver provided an overview of the IEEE and its operations highlight the challenges that IEEE faces and the needs and opportunities of IEEE for future growth and development.
